4. LifeGreen® Checking account monthly fee is \$8 with online statements or \$11 with paper statements (without check images). To qualify for the Monthly Fee with Online Statements, you must be a Regions Online Banking customer who receives only Online Statements for this account. To enroll in Online Banking, visit the Regions Online Banking page at [regions.com](https://regions.com) and complete the enrollment process. You must have a valid Social Security Number or Tax Identification Number in order to enroll in Regions Online Banking. Once enrolled, log in and select the Online Statements link in the top navigation under Accounts in order to activate Online Statements. Monthly Fee with Online Statements will become effective beginning with the end date of the statement period in which Online Statements are activated. If you cancel Online Statements, your account will be subject to the paper statement fee beginning with the end date of the statement period in which Online Statements are cancelled. Avoid the monthly fee by maintaining an average monthly balance of \$1,500 OR with a monthly ACH Direct Deposit (at least one of \$500 or more, or a combined amount of \$1,000). For the average monthly balance, we divide the sum of the ending posted balance for each day in the statement period by the number of days in the statement period. Please note that your account statement only shows ending posted balances and an average balance reflected by those ending posted balances. The ending balance for any day is the opening balance for the next day. For the monthly fee waiver, we count all ACH direct deposits that post to your account during the account statement period, excluding the last day of the period. ACH direct deposits that post on the last day of the statement period are counted in the following statement period.
5. To qualify for a LifeGreen Savings Account, you must have a Regions checking account. The minimum opening deposit amount for a Regions checking account is \$25. The minimum opening deposit amount for opening a LifeGreen Savings Account is \$25 (or \$5 in branch if you set up a monthly automatic savings transfer from a Regions checking account). If you have a LifeGreen Savings account and do not have a Regions checking account, or if you close your Regions checking account, Regions reserves the right to convert your LifeGreen Savings account to a Savings account. We will notify you in advance if we convert your account.
6. Mobile Banking, Text Alerts, Regions Mobile App, and Regions Mobile Deposit require a compatible device and enrollment in Online Banking. To enroll in Online Banking, you must have either a Social Security or taxpayer identification number, or use alternative enrollment procedures available by visiting a Regions branch. We can provide Text Alerts only if you have provided your compatible mobile phone number and/or email address to us; we can provide alerts by text only if you have not opted out of communication via these methods. We provide alerts as a courtesy, and have no liability for any failure or delay to provide an alert to you. We may modify or discontinue these alerts at any time and without notice to you.
